NARRATIVE AND ADDITIONAL INFORMATION:

About 5:50 PM on Tuesday, Sept 29th Officer McHugh in the K422F Unit responded to a call for a struck pedestrian at the intersection of Beacon St and Chestnut Hill Drwy.

Upon arrival officer determined that the actual location was the intersection of St Thomas More rd and beacon St and was met there by Boston College Police Officer Mulvey who was assisting by directing traffic. He stated that he did not witness the accident.

Two witnesses, [REDACTED] listed above, presented themselves. [REDACTED] stated that she had been stopped at the stop sign on St Thomas more Rd when she saw the vehicle driven by [REDACTED] stopped in the road heading East on Beacon Street, waiting to turn left onto St Thomas More Rd. A break in the auto traffic occurred and [REDACTED] vehicle accelerated into the turn. At this time [REDACTED] was proceeding West on beacon on her bicycle and the two "head-on collided". She stated that [REDACTED] smashed into the mini van's windshield and then rolled several times on the street.

[REDACTED], the second witness, concurred with all that [REDACTED] had to say.

Officer then spoke with [REDACTED], the driver of the mini van who stated that he had yielded to oncoming traffic at the spot indicated by the signage on Beacon St. Seeing no oncoming traffic he proceeded. As he was making his turn onto St Thomas More Rd he heard a loud thump and then saw [REDACTED] on the ground.

EMT'S Layton and Mejia from Newton Medic 1 transported [REDACTED] to Beth Israel Hospital for non-life threatening injuries.
